Summary

This position is responsible for ensuring all company safety policies and procedures comply with local, state, and federal rules and regulations including OSHA and DOT. This position reports directly to the Vice President of Human Resources and Safety.

Essential Job Duties

- Develop and execute health and safety plans in the workplace according to OSHA and legal guidelines
- Research regulatory requirements, industry standards, and health and safety best practices
- Communicate guidelines to a multidisciplinary work force
- Evaluate practices and procedures to assess risk
- Develop and conduct training and presentations for health and safety matters and accident prevention
- Monitor compliance with policies and laws/regulations by inspecting employees on the job and operations
- Oversee investigations of accidents and injuries to ensure root cause analysis
- Oversee and manage all workers' compensation claims
- Maintains OSHA Logs
- Identify solutions to issues, improvement opportunities, or new prevention measures
- Ability to train, influence, and motivate members of safety department
- Oversight of Emergency Medical Responders and Severe Weather Training as necessary
- Ensures all safety policies are reviewed as needed and done so in a timely manner
- Oversight of on-site contract security guards
- Oversight of Technical Writer staff
- Maintain employee confidentiality
- Management of safety department staff and budget
